**Ron Horn Quarter Horses**, agent for the above named stallion, is herein referred to as **Breeder**.

This service is engaged subject to following:

1. A 300.00 booking fee, as stated above, is payable with this contract, and the balance of the breeding fee plus all unpaid expenses will be payable upon receipt of an invoice, or when mare leaves the farm, whichever is first. Breedings by shipped semen will be required to pay all fees prior to shipment and are subject to the terms of the Shipped Semen Contract and Shipped Semen Procedures. **The booking fee is non-refundable.** The Breeder requires 48 hours advance notice when the Mare Owner wishes to remove his mare(s) from the farm. The mare (and foal, if applicable) shall be released only upon payment in full of all outstanding invoices, including those from the attending veterinarian.
2. A Photostat **copy of registration papers** shall accompany this contract. For Farm mares, a veterinarian's health certificate, worming, immunization records, and a current Coggins test (within 6 months) shall accompany mare. If these are not presented upon the mare's arrival, the Breeder shall have the attending veterinarian make proper tests and evaluations at the Mare Owner's expense, and mare will not be bred until these test results are in Breeder's possession.
3. The Mare Owner agrees that each mare offered for breeding shall be in sound condition and free from infection or disease. Any mare certified to the attending veterinarian not to be, in his opinion, in sound breeding condition shall not be bred. Mare Owner may substitute another mare within the same breeding season with payment of 200.00 change of mare fee.
4. The Breeder agrees to diligently try and settle the above named mare and shall have sole discretion of determining the best method of breeding such mare. If, however, the mare does not settle, the Breeder shall be held harmless. With farm breedings, there will be no guarantee of a live foal for any mare leaving Ron Horn Quarter Horses before being checked safe in foal by the attending veterinarian.
5. **Live Foal Guarantee.** Live foal means the foal shall stand and nurse. It is understood that if the mare proves barren, aborts her foal, or if the foal is born stillborn, a return season will be guaranteed the following year only, providing proper notification is given. Proper notification shall be defined as follows: Written certification by a licensed veterinarian within seven days that the mare has slipped or produced a nonviable foal. Mare Owner certifies that such abortion or death did not result from an act or omission of the owner subsequent to the mare's departure from Ron Horn Quarter Horses. Booster Rhinopneumonitis vaccinations must be administered as indicated by the individual drug manufacturer as the mare progresses through her pregnancy. Failure to do this will void the Live Foal guarantee. If a change of mare is requested and granted, a \$200.00 change of mare fee is due except in cases of death of mare.
6. The breeding season in force for this contract shall begin February 15 and close July 1, of the year dated on contract.
7. It is further agreed that should the above named stallion die or become unfit for service, or if the above named mare dies during the breeding season, then the Mare Owner may substitute another mare or breed the above named mare to another stallion owned by Ron Horn Quarter Horses that is agreed to by both the Mare Owner and Breeder. Stud fee is non-refundable.
8. A breeder's certificate will be issued to Mare Owner after all expenses are paid in full and upon notification of the birth of the foal.
9. **Waiver of Liability.** It is understood that the breeding farm, it's owners, employees, and guests shall not be liable for any injury, escape, or death of any horses on it's premises. The above named Mare Owner whose horse(s) is/are under care of Ron Horn Quarter Horses, will not be liable or responsible for any damage, injury, or death to the breeding farm stallions, employees, veterinarians, or other animals in the care of Ron Horn Quarter Horses, whether or not caused by his horse(s).
10. The signing of this contract entitles Ron Horn Quarter Horses to charge ten percent annual interest on all past due invoices. Past due billing is defined as those amounts not paid within thirty days of invoicing.
11. This contract is governed by the laws of the State of Oklahoma. All accounts due and payable in Canadian County, Oklahoma.
12. Paint Color Guarantee. Rebreed in 2009 with a \$300 rebooking fee.
13. This contract not valid unless completed in full.
14. **Cooled Shipped Semen - Shipped Semen Contract must also be completed.**

2. Send Check, money order, or credit card form for Stud Fee and Shipment Fee.

**FEES MUST BE PAID PRIOR TO SHIPPING** (in US dollars)

\$300.00 To Canada (*Includes Collection Fee and Shipping Cost*)

*A shipment fee is due each time a semen shipment is ordered and shipped*

*There is a \$25.00 courier charge for shipments sent counter-to-counter.*

3. Send \$30.00 or add to credit card for disposable container purchase. If an Equitainer is requested instead, a \$225.00 deposit is required prior to shipment or you may send your own Equitainer for use. **DO NOT RETURN DISPOSABLE CONTAINERS**

***Equitainers must be received back at RHQH two days after insemination date or late fees will accrue at a rate of \$25.00 per day late. ALL RETURN SHIPPING COSTS ARE THE MARE OWNERS EXPENSE. .***

4. **You MUST contact Ron Horn QH by phone or fax 6:00 p.m. C.S.T. the evening PRIOR to a collection day to order semen.**

Stallions are collected on **MONDAY, WEDNESDAY and FRIDAY**. You may CANCEL that shipment up UNTIL 7:00 a.m. C.S.T. on the day of the shipment at no penalty. The semen may used ONLY for the designated mare. Late orders, if available, are subject to a \$25.00 late order charge.

5. **Please** contact Ron Horn Quarter Horses when your mare has been checked for pregnancy and advise us of her status. We require an ultrasound examination at 14-16 days post ovulation and again at 24-35 days to confirm pregnancy to insure your live foal guarantee.

6. Ron Horn QH will ship to one mare through a total of **three** heat cycles. If after three cycles the mare does not conceive, we will require a consultation with your veterinarian before any additional shipment is ordered.

# RON HORN QUARTER HORSES

## SHIPPED SEMEN PROCEDURES

FAX or MAIL the Breeding Contract and the Shipped Semen Contract with payment of the Booking Fee. The balance of the Stud Fee, the Shipment Fee and 30.00 for purchase of a disposable container must be paid prior to ordering a shipment. WE ACCEPT CHECK, CASHIERS CHECK, and VISA AND MASTERCARD FOR ALL OR PART OF THE FEES. If an equitainer is requested, a Credit Card Form must be sent in for the deposit. No equitainer charges will be put on the card unless it is returned damaged or late. If you do not wish to send a Credit Card Form, then a deposit of \$225.00 must be sent via cash or check or you may send us an equitainer for us to use for your shipment.

1. Give the yellow copy of the shipped semen contract to your veterinarian/breeding manager. Please point out to him/her that the stallions are collected and shipped on **Monday, Wednesday and Friday**.
2. Stallions are collected **VERY** early in the mornings on collection days, therefore we **MUST** be contacted by 6:00 P.M. C.S.T. the evening **PRIOR** to a collection day to order semen. This will allow us to prepare the required paperwork and shipping labeling that evening. You may contact us by leaving a message on our answering machine or by fax. Make sure you specify the mare's name and the type of shipment you need (overnight or counter-to counter for same day). You may cancel the shipment up until 7:00 A.M. C.S.T. on the day of the shipment at no penalty. PLEASE INFORM your vet/breeding manager of this to avoid any miscommunication. DO NOT request a shipment via email.
3. We can ship either overnight or same-day (via airline). Your veterinarian will make that decision based on where your mare is in her cycle. Airport shipments will be assessed an additional \$25.00 courier fee.
4. When you receive your shipment DO NOT OPEN IT until your veterinarian is present and ready to inseminate your mare.
5. The container will arrive with a detailed analysis of the semen and the breed paperwork. Make sure the vet fills out and signs the breed paperwork then mail the copy that goes to association directly to them and the stallion owners copy back to us.
6. If a disposable is not purchased, our Equitainer must be returned to Ron Horn Quarter Horses and be RECEIVED BY US TWO BUSINESS DAYS after insemination or LATE FEES will accrue at \$25.00 a day. Please inform your vet and breeding farm as to this policy to avoid any penalties. Return mailing fees are at mare owner's expense and may not be charged to RHQH or sent freight collect.
7. You must notify us when your mare has been checked in foal. We require an ultrasound examination at 14 – 16 days post ovulation to be repeated at 26 – 35 days to insure your live foal guarantee.
8. If your mare is not in foal after three cycles or 60 days from the first shipment, we will confer with you and your vet and may recommend changes.
